An email notification is sent to the Publisher stating that a new content needs to be reviewed</li> <li>c. The Publisher reviews the content can edit in the content and can approve the content to be published on the portal, asks the Content Editor to modify the content and can enter comments or can reject the content</li> <li>d. If content is asked to be modified an email notification is sent to the Content Editor with the comments to modify the content then is sent once again for the Publisher approval</li> </ul>
